

Generating Facilities

- 3 nuclear plants (6 units)
- 11 coal-fired plants (54 units)
- 9 simple-cycle natural gas plants (87 units)
- 3 combined-cycle natural gas plants (7 units)
- 29 hydro plants (109 units)
- 1 pumped storage station
- 16,000 miles of transmission line



TVA Supply Chain

- \$3.5 billion annually in materials and services
- Inventory exceeds \$500 million
- From turbine blades to paper
- Serve operational needs of a diverse power fleet (nuclear, fossil, hydro, natural gas, etc.)
- Partial listing of opportunities: Electric Motor Repair, Scaffolding Materials & Services, Refractory Materials & Services, Elevator Repair & Parts, Roofing Replacements, HVAC Parts & Services, Furniture, Paving, Nuclear Safety Related Cable, Boiler Leak Repair Services, Security Services
